

Two Day Trial – 8th & 9th November 2025

1. Jurisdiction

The competition shall be held under the National Sporting Code, the Environmental Code and the Standing Regulations of the ACU, these Supplementary Regulations, which shall have been submitted to the ACU and any written instructions, which may be issues relating to the event.

2. Eligibility

The event is open to Riders who hold a valid ACU or SACU Trials Registration card or an ACU/SACU competition license. Any Rider from another FMN must produce a license issued by their FMN together with start permission and proof of personal accident insurance.

Riders must also hold a current driving license for the machine on which they enter.

Permanent Jersey residents are required to be full members of the JMC & LCC and provide an experienced observer, please choose either Saturday or Sunday on your entry form, this will be allocated on a first come first served basis.

Youth riders who have reached the age of 16 may apply for an adult license with the ACU and take part in the event. With the aid of an assistant who must meet the road legal requirements for the competition machine who will ride the road sections of the event on behalf of the competitor. The Competitor shall then make his own transport arrangements for the road sections.

This event is open to solo trials machines only.

3. Entries

The entries will be accepted in order of receipt and the maximum number of entries will be 100.

Classes from hardest to easiest are:

Expert (A) Clubman Expert (B+) Clubman (B) Novice Plus (C+) Novice (C)

Any online entries received without payment of the entry fee, will not be accepted until full payment is received. **Entry fee is £55 per competitor and payable at time of entry.**

Please take extra care when completing the online form as incorrect details may lead to entries not being accepted.

Entries will close at midnight on Sunday 26th October 2025.

Should you enter after this date, you will be charged an additional late entry fee of £10 or you may be refused an entry if our maximum rider number has been reached. This will be at the committee's discretion with the Clerk of the Course having the final decision. Should you wish to amend your entry, i.e. change the class you have selected to ride, you must email trials@jerseymotorsport.com by midnight on **Sunday 26th October 2025** in order that rider numbers and other details can be determined before sending final instructions out.

The only other time you can change class is when you sign on, however you will be charged a £20 fee.



4. MACHINE EXAMINATION

Scrutineering will take place on Saturday 9th November 2025 at the service park.

It is recommended that all machines be fitted with a lanyard operated cut out device as described in the ACU Handbook (page 8, TSR8 of Trials Standing Regulations)

All riders must clearly display a yellow registration plate on their bike, it must be positioned vertically and be visible at all times whilst on the public road, you will be refused to start should your plate not be adequate, judges of fact will monitor this throughout the event.

An environmental mat should be positioned underneath the machine whilst parked and whilst refueling as per ACU Environmental Code.

All riders should ensure their bikes are registered, insured and compliant with either daytime MOT requirements (UK) or in the case of Jersey or Guernsey registered machines which should comply with the Jersey Road Traffic Act.

5. Signing on

Competitors must report to sign on and collect their numbered bib before the event start time. Further details will be provided in the Final Instructions.

You will need to present either a paper copy OR a digital version of your license, failure to do so may result in you being refused to start. One day licenses are available at a cost of £5.00 per license and must be paid for when entering the event online.

6. Numbers

Riders must wear numbered bibs or number boards supplied which must be visible at all times and must be returned to the "sign off" officials either on retiring or at the end of Day 2 when you will be signed off as a finisher and receive your finishers award. Should you misplace or lose it you will be asked to pay for a replacement to be purchased at a cost of £50.

7. Course/Route

This Trial includes the use of public highways. Road marking will be used as necessary. **Sections must be taken in the correct sequence;** any competitor failing to do so will be penalised or excluded from the results at the discretion of the Clerk of the Course. **This will be policed by club officials.**
